How we use player information

This notice describes what information CIYMS Youth Cricket Section (the Cricket Club) holds about you, why we hold it and how we use it

What is data?

Data is any information which relates to you - the individual. Personal data is information which can identify you. An example of personal data is your full name, address and date of birth.

Why do we collect and hold your data?

We collect and use your information to carry out our functions as a Club with support, training and development as a cricket player and providing appropriate pastoral care as a club member.

The information which we collect, hold and share includes:

- Personal information such as name, date of birth and address
- Parent or guardians email address and phone number
- Any disclosed medical information
- Any special needs that may be required
- Video and photographic images

The Legal Bit

We process your information in order to conduct our business and pursue our legitimate interests to manage and administer your membership and involvement with the club.

Storing your data

We hold your data at least for **1 year** after you leave the club. It is then destroyed in a secure manner.

Requesting access to your Personal Data

The accuracy of your data is important to us. If you (or your parents/ guardians) believe that the information we hold about you is inaccurate you can ask for it to be corrected.
